The **PARTY OF THE FIRST PART** shall:

1. Pay a **NON-REFUNDABLE FEE of \$75.00** to the **"PLUM COMMUNITY ROTARY."**
2. Maintain the designated space in Larry Mills Park of Holiday Park, Plum Borough in the condition in which it was acquired by the **"PARTY OF THE FIRST PART"** and keep the space and its adjacent areas free of debris.
3. Vend only those goods which meet this description:
  - a. goods which are substantially fabricated by hand and are not **mass-produced**;
  - b. non-electrical goods which are clearly intended for the use of producing home-made foodstuffs;
  - c. home-made foodstuffs.
  - d. **No Flea Market Items** - at the discretion of Festival Committee.

4. SET UP IN THE ASSIGNED SPACE BETWEEN 9 A.M. AND 3 P.M. ON FRIDAY, JULY 29<sup>TH</sup> AND BETWEEN 9 A.M. AND NOON ON SATURDAY, JULY 30<sup>TH</sup>.

5. **THERE WILL BE ELECTRICITY AVAILABLE FOR THE CRAFTERS.** Please fill out the electrical request form (available on plumcommunityfestival.com) and return with this agreement.

6. Observe any and all directions given by the duly-authorized representatives of the Plum Community Festival Committee.

The "**PLUM COMMUNITY FESTIVAL**" does not guarantee the initial condition of each space except that it will be in the condition normally maintained by Plum Borough.

**THE "PARTY OF THE FIRST PART" RECOGNIZES THAT THE "PLUM COMMUNITY FESTIVAL" MAY TERMINATE THIS AGREEMENT FOR ANY VIOLATION OF THE AGREEMENT OR CIVIL OR CRIMINAL LAWS.** I, the "**PARTY OF THE FIRST PART**", shall abide by this agreement:
